

Agreement to Provide Insurance

I understand that to provide protection from serious financial loss, should an accident occur, my installment contract requires the vehicle to be continuously covered with insurance against risk of fire, theft and collision. Accordingly, I have arranged for the required insurance through the insurance company shown below and have requested my agent to note Dependable Credit Corp's interest in the vehicle and endorse the policy with a loss payable endorsement in favor of Dependable Credit Corp at the address listed above.

Insurance Power of Attorney

I agree at all times to keep the vehicle insured with comprehensive collision, fire and theft and a minimum amount of deductible of \$1,000.00, endorsed to protect Dependable Credit Corp as additional loss payee with a licensed insurance company. If I fail to insure my vehicle, Dependable Credit Corp may do so and I agree to pay the cost.

I agree that any insurance moneys payable by reason of damage to or loss of the vehicle shall be paid directly and solely to Dependable Credit Corp and will be used to pay my debt to Dependable Credit Corp. If the vehicle is lost or damaged, Dependable Credit Corp can use the insurance proceeds to replace or repair it, or to repay any amounts I owe to Dependable Credit Corp, and I agree that, if necessary, Dependable Credit Corp can settle, negotiate or resolve any insurance claims or sign any insurance checks on my behalf whether it's a first party claim or a third party claim.

I agree that loss, damage to the vehicle shall not affect my duty to make the payments under this contract.

I agree that all insurance checks, whether from the direct insurer of the vehicle, or by a third party insurance company, will be paid directly to Dependable Credit Corp.

Any sums in excess of the amount necessary to satisfy the indebtedness owed to Dependable Credit Corp will be paid to the borrower by Dependable Credit Corp.
